In producing herewith the 03 (Three) accused persons namely (1) Nagen Sarkar (40) S/O - Jagannath Sarkar of Krantihat Paulpara PO Krantihat PS Malbazar Dist Jalpaiguri, C/O Chinmoy Some, Madhya Shantinagar PS Bhaktinagar Dist Jalpaiguri (2) Shankar Mahanta (45) S/O Late Madhusudhan Mahanta of Karunamayee Kalibari Road Shantinagar PS Bhaktinagar Dist Jalpaiguri and (3) Ganesh Choudhury (25) S/O Mahendra Choudhry of Madhya Shantinagar, Pipeline Kuti Mill PS Bhaktinagar Dist. Jalpaiguri along with the following seized articles with seizure list;

(1) Cash Rs. 410,200/- (Four Lakh ten thousands two hundred only in the following denomination:-

I SI Partha Sarath Das, O.C. Ashighar OP, under Bhaktinagar PS lodged a written complaint against the above noted accused persons to the effect that on 21.06.2020 at 14.25 hrs received information that a Online betting was going on regarding test Cricket match in between India Vs Newzeland & European cup 2021 inside the house of Nagen Sarkar at of Madhya Shantinagar PS Bhaktinagar Dist Jalpaiguri. Accordingly I diarized the matter vide Ashighar OP G.D.E. No. 548 dtd. 21.06.2020 & informed the matter to I/C BKN PS and as per his kind direction myself along with SI Pradip Kr Singha, ASI Inzamamul Houque, Constr- 877 Munna Ahmed CV- 1016 Amrit Roy all are of Ashighar OP left for the spot to verify the veracity of information. On arrived at 14.45 hrs at the spot found that the above noted accused persons and others are engaged in online betting with the help of Mobile phone to each other by cash & online transation to wrongful gain and wrongful loss and on seeing the police party they try to flee away from the spot but on hot chased police party apprehended the above noted accused persons namely (1) Nagen Sarkar (40) S/O - Jagannath Sarkar of - Krantihat Paulpara PO Krantihat PS Malbazar Dist Jalpaiguri (2) Shankar Mahanta (45) S/O Late Madhusudhan Mahanta of Karunamayee Kalibari Road Shantinagar PS Bhaktinagar Dist Jalpaiguri and (3) Ganesh Choudhury (25) S/O Mahendra Choudhry of Madhya Shantinagar, Pipeline Kuti Mill PS Bhaktinagar Dist. Jalpaiguri. I searched the above noted accused persons and found the following articles from their possession which I seized under proper seizure list as they failed to produce any valid lisenace for their this type of gambling.

(1) Cash Rs. 410,200/- (Four Lakh ten thousands two hundred only in the following denomination:-
i) 500x800= 400000/-, ii) 200 x 9=1800, iii) 100 x 83=8300/-, iv) 50 x 02=100/-.

In this circumstances it is clear that the above noted accused persons namely (1) Nagen Sarkar (40) S/O Jagannath Sarkar of - Krantihat Paulpara PO Krantihat PS Malbazar Dist Jalpaiguri (2) Shankar Mahanta (45) S/O Late Madhusudhan Mahanta of Karunamayee Kalibari Road Shantinagar PS Bhaktinagar Dist Jalpaiguri and (3) Ganesh Choudhury (25) S/O Mahendra Choudhry of Madhya Shantinagar, Pipeline Kuti Mill PS Bhaktinagar Dist. Jalpaiguri violated the provision of W.B.G & P.C Act. Accordingly I arrested them issuing proper memo of arrest.

Hence I Pray before your kind honour that a specific case may kindly be started against the above noted accused persons and arrange for its investigation.
