Sub : Complaint against Sushil Oraon


On 19/03/2021, while doing regular patrolling within the Reserve Forest at Trihana Block under Bagdogra Range & Tarabari block under Bamonpokhri Range, Staff of Bagdogra Range & Bamonpokhri Range, and ADFO Bagdogra, of Kurseong Division, sighted 1 Pokhlin, 2 Truck, & 3-4 Tractor along with some labour loading /welling boulder at River bed from reserve forest illegally, when we charged the vehicles all the labours & the Pokhlin, trucks & other tractors managed to be fled away & we apprehended one truck No. **BR-11-GB-8714** when we are discharging Govt. duty to protect forest & wild life and also protect Govt. property. Sri. Sushil Oraon S/o. Late Bajroo Oraon, Village Trihana Tea Garden, Po. Belgachi, Dist Darjeeling came along with 7-8 others, stopped our vehicle to move out from the site by placing boulders in the road, and prevented forcefully to discharge Govt. duty by saying that we have to free the vehicle & should leave the place, otherwise we will the life threaten situation, during the argument accused Sushil Oraon admitted that he is purely engaged in this kind of illegal mining of RBM from reserve forest for long time, When I along with staff try's to apprehended Sushil, he gave pushed our staffs and ran away by saying that he will take revenge for this.


Today at around 7.15 am when ADFO, Bagdogra along with team went to the same place i.e. reserve forest Trihana block under Taipoo Beat and same situation has arised. 2-3 tractors along with labour ware collecting RBM from reserve forest illegally. When I along with staff went apprehended the vehicles, all managed to fled away, but one tractor no. WB73E-4949 Model **Sonalika Di 35** apprehended but soon after this Sushil and some 10-15 people came and gheraowed the duty vehicle of ADFO, Bagdogra & argued to free the vehicle otherwise he should face Jhamela and that may be life threaten. When after staffs arrived that place, Sushil has to be fled away and 3rd time he came to Taipoo Beat along with his team when ADFO, Bagdogra were inspecting the work in Beat campus, there also Sushil was trying to provoke his team to free the vehicle & starting arguing to free the vehicle & legalize the illegal location from Reserve Forest & causing damage of Forest & loss Govt. Property.

It is found that this man Sushil and his team doing nuisance every time retrained the Govt. officials to discharge his duty peacefully, provoking villagers by that way the situation of the field were getting deteriorated day by day.

Thereby I am praying to take stringent action within the existing acts & rules that allow as the Govt. official to discharge his call of duties.
