Respected Sir,

With due respect, I Dilwara Khatun (53 yrs) wife of late. Darajuddin Ahmad resident of Harekrishna pally bagdogra PO & PS Bagdogra was complain against the following person namely

- ① MD Abul (70 yrs app.)
 - ② MD Parukh (36 yrs app.)
 - ③ MD Khadim (33 yrs app.)
 - ④ MD Rustam (30 yrs app.)
- all are residing at Kestopur Halal PO & PS Bagdogra. That today around

10:00 hours, I along with my daughter Rubinc Ahmad (29 yrs) went to old house located at Kestopur halal. Then around 10:15 am, the above accused forcefully entered our accused house and started heated argument with us.

Thereafter the above accused attacked us with sharp weapon and torn my daughter and mine clothes. Not only this, the above accused snatched my gold necklace, my purse (which consist of money amount to Rs 5000 and some valuable documents). This is a serious offence that the above accused did. That the above accused has criminal intent to hurt me and my daughter and run away with valuable goods.

Therefore kindly register the FIR and take necessary legal steps as I am seriously injured at my head and treated primarily bagdogra hospital and from there doctor referred for better treatment.
