In producing herewith two accused persons namely 1) Laishram Malemnganba Singh (32) S/o L Ibomcha Singh of Sorem Mayai Likai, Poiroukhongjil, Yairipok, PS- Andro, Dist.- Imphal, Manipur. 2) Thingujam Deepu Singha (27)yrs S/o Thingujam Dilip Kumar Singh of Charangpatpat, Mamang Leikai,, PS- Thoubal, Dist.- Thoubal, Manipur along with the following seized articles under seizure as per seizure list:

1. One Blue Colour Baleno Maruti Suzuki bearing registration No. UP 70FJ 7961 having Engine No. GA130H30090010 and Chassis No.: MA3E8B22SJH539408

I, SI Ganesh Roy of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused persons to the effect that on today i.e 21.06.2021, while performing CS van duty vide MCC No. NJP PS MCC No: 1536/21 Date: 21.06.2021. at about 18:15 hrs received a specific source information that two persons would be coming from Shambal (Uttar Pradesh) and proceed towards Manipur with a stolen vehicle for its clandestine disposal. Accordingly I informed the matter to SI Samir Tamang, O/C New Jalpaiguri PS accordingly I, diarized the fact in GDE vide NJP PS GDE No 1033 Date: 21.06.2021. At 18:15 hrs I, along with C/ 1062 Goutam Shil and C/1041 Krishna Gurung both of NJP PS left PS for Fulbari Mahananda Barrage At about 18:40 hrs we arrived at Fulbari Mahananda Barrage and parked the vehicle at considerable distance and proceeded towards Fulbari Mahananda Barrage and ambush there. At 19:15 hrs we saw that one Baleno Vehicle bearing registration No. UP 70FJ 7961 with the two persons coming from Phansidewa Side and proceed toward Siliguri Side. The Police Team instruct them to stop but they violate the Police signal and tried to fled away in a suspicious manner, but the Police Team manage to intercept the said vehicle and apprehend the drivers and his associate. After prolonged interrogation they disclosed their name as 1) Laishram Malemnganba Singh (32) S/o L Ibomcha Singh of Sorem Mayai Likai, Poiroukhongjil, Yairipok, PS- Andro, Dist.- Imphal, Manipur. 2) Thingujam Deepu Singha (27)yrs S/o Thingujam Dilip Kumar Singh of Charangpatpat, Mamang Leikai,, PS- Thoubal, Dist.- Thoubal, Manipur On demand they failed to produce any valid documents in respect of Vehicle and also failed to give satisfactory remarks in this regards. Hence, there is sufficient reason to believe that the vehicle is stolen one they admit that they procured the same from Uttar Pradesh and proceeds towards Manipur for its clandestine disposal for their wrongful gain. The whole search and seizure was made in between 19:30 hrs to 20:10 hrs.

Accordingly, I seized the above noted Baleno Vehicle bearing registration No. UP 70FJ 7961 having Engine No. GA130H30090010 and Chassis No.: MA3E8B22SJH539408 from the conscious possession of the accused person noted above and subsequently I arrest the above noted accused persons U/S 41 Cr.P.C. after issuing proper memo of arrest and inform them ground of arrest.

Under the above circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused 1) Laishram Malemnganba Singh (32) S/o L Ibomcha Singh of Sorem Mayai Likai, Poiroukhongjil, Yairipok, PS- Andro, Dist.- Imphal, Manipur. 2) Thingujam Deepu Singha (27)yrs S/o Thingujam Dilip Kumar Singh of Charangpatpat, Mamang Leikai,, PS- Thoubal, Dist.- Thoubal, Manipur and arrange for its investigation.
