- (i) HIT BEER, 05 CARTOONS, EACH CARTOONS 12 BOTTELES, TOTAL 60 BOTTLES... 60 x 140 = 8,400/- RS.
- (ii) ROYAL BLUE( SIKKIM) Premium Whisky 06 Cartoons, each cartoons 12 BOTTELES, TOTAL 72 BOTTLES.....72 x 288 = 20,732/- RS.

- (iii) One (01) white colour Maruti van bearing no. WB 72B 6686.


I, L.S.I. Niden Sherpa of Bhaktinagar P.S., Dist.- Jalpaiguri do hereby lodge this written complainant against accused persons namely i. Sita Thapa(F/30) D/O. Lt. Deepak Thapa of Salbari, near Rehab Centre, PS. Pradhannagar, Dist.Darjeeling and ii. Gopal Thapa(M/25), D/O. Lt. Deepak Thapa of Salbari, near Rehab Centre, PS. Pradhannagar, Dist.Darjeeling to the effect that on 23.06.2021 at about 07. 55 hrs I received a source information that two person are coming with one Maruti van bearing no. WB 72B 6686 along with huge quantity of ID liquor. As per direction of I/C Bhaktinagar PS, myself along with C/953 Himangshu Barman and Civic 27 Mithun Sarkar both of BKN PS,SPC had been to Sevoke road near Sona Petrol Pump area with Govt. vehicle and as per source after hot chasing I managed to stop the above noted vehicle near Check post under Bhaktinagar PS,SPC. On searching Maruti van bearing no. WB 72B 6686 found that the above noted accused persons on the vehicle and were carrying 11(Eleven) no cartoons in the vehicle and contained with above noted articles. On being asked they failed to produce any valid documents in respect of said articles. Accordingly seized the above noted articles along with Vehicle under proper seizure list from their possession and I arrested them u/s 41 Cr.p.C as the above noted accused persons violating provision of B.E. Act .The search; seizure and arrest were made in between 08.35 hrs to 09.05 hrs. of 23.06.2021 .

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons namely i] Sita Thapa(F/30) D/O. Lt. Deepak Thapa of Salbari, near Rehab Centre, PS. Pradhannagar, Dist.Darjeeling and ii] Gopal Thapa(M/25) S/O. Lt. Deepak Thapa of Salbari, near Rehab Centre, PS. Pradhannagar, Dist.Darjeeling) under proper section of law and arrange for its investigation .
