Ganesh Barman of Bhangapol, P.S - MTG, Dist - DJG, (iv) Sourav Mandal (29), S/O Sapan Mandal of Sultanpur, P.S - English Bazaar, Dist - Malda, (v) Amrit Kr. Singh (23), S/O Gulbadan Singh of Naxalbari, P.S - Naxalbari, Dist - DJG under proper section of law and arrange for its investigation.
