Sir,

In producing herewith five (06) arrested accused persons namely (i) Md. Sabirul @ Raju (35 Yrs./M) S/O Late Md. Rafikul of Balijore, P.S- Itahar, Dist- Uttar Dinajpur. A/P Biswas Colony, P.S- Matigara, Dist- Darjeeling. (ii) Shiba Roy (18 Yrs./M) S/O Gopal Ch. Roy of Biswas Colony, P.S- Matigara, Dist. Darjeeling (iii) Abhishek Minj (18 Yrs./M) S/O Bipin Minj of Central Duar, Bara Kuthi Line, P.O- Pana Busty, P.S- Kalchini, Dist. Alipurduar (iv) Kamal Sarkar (35 Yrs./M) S/O Lal Chand Sarkar of Ghughumali, P.S Bhaktinagar, Dist.- Jalpaiguri (v) Amit Roy (21 Yrs./M) S/O Dhananjay Roy of Ghoklajote, P.S- Matigara, Dist- Darjeeling. And (VI) Charan Barman (22 Yrs./ M) S/O Lt. Amit Barman of Ghoklajote, P.S- Matigara, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (i) One iron made Bhujali measuring 19 inches (approx) including wooden butt from the possession of Abhishek Minj which was kept concealed on his back side,
- (ii) One iron made Hasua measuring 16 inches (approx) in length including handle measuring 6 inches (approx) from the possession of Md. Sabirul @ Raju which was kept concealed on his back side,
- (iii) One iron made chapper measuring 14 inches (approx) with handle in length which was hold by Kamal Sarkar on his right hand.
- (iv) One iron made 'Dhai'(iron made breaking instrument) 21 inches in length from the possession of Charan Barman which was kept concealed on his back side,
- (v) One iron made Crowbar measuring 35 inch (approx) in length from the possession of Shiba Roy which was kept on his right hand,

I, PSI- Newton Biswas, S/O- Nirmal Biswas of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely Md. Sabirul @ Raju, Shiba Roy, Abhishek Minj, Kamal Sarkar, Amit Roy, Charan Barman and others namely Roshan Ali, Satyajit Sha , Bijay Dey, Prosenjit to the effect that today on 23.06.2021 at 00.45 hrs received a sources information that 14/15 youths have assembled at Himachal Bihar beside Inspiria College, under Matigara PS with a view to commit dacoity in a house at Himachal Bihar. The fact was diarized in GD vide Matigara PS GDE No- 1078 dated 23.06.2021. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI- Subhendu Das, ASI Nitai Ch. Mandal, C/986 Rajib Sarkar C/1008 Kanak Roy, C/1035 Santosh Rabidas, CV/387 Sukumar Barman and CV/155 Sukumar Das left for the place to work out the information. At about 01.00 hrs after reaching near Inspiria College under PS- Matigara I met my source and as pointed by the source we started walking towards Inspiria College and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted six (06) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Himachal Bihar area.

I thereafter, seized the above noted weapons under proper seizure list and labelled duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.35 hrs to 02.15 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Himachal Bihar area. It is also revealed from them that Roshan Ali, Satyajit Sha, Bijay Dey, Prosenjit and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Md. Sabirul @ Raju (35 Yrs./M) S/O Late Md. Rafikul of Balijore, P.S- Itahar, Dist- Uttar Dinajpur. A/P Biswas Colony, P.S- Matigara, Dist- Darjeeling. (ii) Shiba Roy (18 Yrs./M) S/O Gopal Ch. Roy of Biswas Colony, P.S- Matigara, Dist. Darjeeling (iii) Abhishek Minj (18 Yrs./M) S/O Bipin Minj of Central Duar, Bara Kuthi Line, P.O- Pana Busty, P.S- Kalchini, Dist. Alipurduar (iv) Kamal Sarkar (35 Yrs./M) S/O Lal Chand Sarkar of Ghughumali, P.S Bhaktinagar, Dist.- Jalpaiguri (v) Amit Roy (21 Yrs./M) S/O Dhananjoy Roy of Ghoklajote, P.S- Matigara, Dist- Darjeeling, (VI) Charan Barman (22 Yrs./ M) S/O Lt. Amit Barman of Ghoklajote, P.S- Matigara, Dist- Darjeeling, (vii) Roshan Ali, (viii) Satyajit Sha , (ix) Bijay Dey, (x) Prosenjit and others and arrange for its investigation.
