


In producing herewith one arrested accused person namely Rabi Roy (50) S/O Late Jotin Roy of 2 No. Panchanoy Colony, Near Kali Mandir P.S Prodhana Nagar Dist :- Darjeeling along with following seized articles viz i) 16 (Sixteen) bottle Himalayan Gold 60 UP country spirit containing 600 ml each bottle, ii) 15 (Fifteen) bottle Himalayan Gold 60 UP country spirit containing 300 ml each bottle under proper seizure List along with memo of arrest.

I ASI Debasish Das of Pradhannagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused person to the effect that on 22.06.21 at 20:20 hrs received a secret source information that one person illegally selling liquor inside his house at 2 No. Panchanoy Colony, Near Kali Mandir P.S Prodhana Nagar Dist :- Darjeeling illegally and diarized the matter vide Pradhannagar PS GDE No. 1206 dated 22.06.21.

Accordingly, I informed the matter to I/C Pradhannagar PS, SPC and as per kind direction myself along with ASI Ashit Kumar Singha and CV 128 Ajoy Kr. Sahani, CV131 Ranjan Sharma, CV 242 Rakesh Mamger left for the spot by govt. vehicle to verify the veracity of source information. On reaching there I tried to search disinterested witnesses but due to lock down no body was present there. Then we cordoned the area and apprehended the person. Accordingly, search was conducted in his house and above noted liquors was recovered. On demand the said person failed to produce any valid document in respect of the recovered liquors. On being asked he admitted that he had been selling liquors illegally since long without any valid license for his illegal gain. Hence, It is violation of West Bengal Excise Act. Accordingly, I seized the liquors from the house of the said accused person under proper seizure list duly signed by him and the witnesses and arrested him U/S 41 Cr.P.C after maintaining all formalities of arrest and intimating him the reason of arrest. The Seizure was made on 22.06.2021 from 21.15 hrs to 21.30 hrs.

Therefore, I request you to start a specific case under proper section of Bengal Excise Act- 1909 as amended till date against the arrested accused Rabi Roy (50) S/O Late Jotin Roy of 2 no. Panchanoy Colony, Near Kali Mandir P.S Prodhana Nagar Dist: - Darjeeling and kindly arrange for its investigation.
