Dear Sir/Madam

With due respect, I want to say that my name is Ruku Mazumdar Paul, residing at Bhujipani chott, Bagdogra, near Bhujipani market, Jivan Jyoti church.

I got married on 25/02/20 to Mr. Biraj Ch. Paul, residing at Yusuf Saroi, Pin code. 110049, New Delhi, working as Senior Resident at AIIMS, Delhi.

After few months of our marriage Biraj has started harassing me, abusing me with his dirty words, spitting on my face and telling me that he will give me divorce again and again. I initially told him not to do this & I am not liking this but he never stopped, day by day his cruelty towards me has increased. He did not allow me to visit my parents house even at my brother's marriage last year & when my dad was admitted to hospital this year.

He kept on harassing me by saying that I have affairs with others, he crossed all the limits by saying that I am my brother's rakhail, I sleep with my father, my mother does prostitution to me.

after one year of my marriage he took me to his younger brother's marriage on 27-02-21 to Singimari Meghalaya via my home Bagdogra, & he took all my gold jewellery to Singimari, half of that he took to Singimari & half of that he took Delhi when we returned on

At his brother's marriage, he insulted me in front of everyone by saying that I slept with the commerson, I saw my stomach to people in saree and kept on telling bad about my character.

I told him to keep me in my parent's home for few days since after one year I visited but while returning from Singimari to Bagdogra, he shouted like anything and took me to Delhi. After reaching Delhi, his torture and harassment has reached all the limits, he swipe off my sindur, took away my shakha-pola and kept all my items in his locker. Before going to office and after coming from office he is unstoppable, his abusive language was so tough to handle that I tried to drink "Final" and then he holds my hair and pulled me and said he will beat me with cylinder.

He said that we are koth-pata jath, has not given anything to him.

He himself booked my ticket and ask me to ask my parents to pay the flight fare, then somehow I kept quite and waiting to reach Bagdogra.

I reached Bagdogra on 14th March, 2021, but unfortunately he has not stopped his torture, he is calling me and texting me again & again and using abusive words and I have clearly told him that "I DO NOT WANT TO TALK WITH YOU NEITHER ON CALL NOR ON MSG" but he is unstoppable and still he is continuously calling me again & again and asking me why you are not coming and do I need divorce etc.

He has not even guilty for what he has done to me & telling he has not done anything wrong to me.

Now he has been telling me that he will come to Bagdogra and will take me to Delhi & no one can stop him since I am his wife, even though I have told him that I WILL NOT GO WITH HIM & I DON'T WANT HIM TO COME

HERE.

My parents & brother blocked him on phone because of his repeated calls & messages.

so I just want to stay with my parents & do not want to go with him

Me and my family have failed to stop him, so we need your kind help on this & requesting you to do the needful
