Dear Sir,

I, Miss Gargi Choudhury, D/o – Mr. Adhir Kumar Choudhury and Smt. Aparna Choudhury is residing at Bagha Jatin colony main road (near Jhil mill park), Po. + P.S – Pradhanagar, Dt. – Darjeeling beg to inform as under:-

With utter dismay I beg to state that Sri Debashis Saha resident of Khudiram Children parks, Milanpara, Po. + P.S – Raiganj, Dt.- Uttar Dinajpur, W.B has been harassing me and my family since last 3 months. I have no other option but to seek your intervention to put an end to this trauma caused to me and my family.

I am hereby mentioning to you in details the acts inflicted upon me and my family by Sri Debashis Saha. Firstly he has uttered cuss language to my family and threatened to defame me publicly. Secondly he has kept in his possession explicit nude photographs of me without my knowledge and permission and has circulated those photographs to me and my family and has threatened to make of public. Thus indulging in the act of voyeurism. He has attempted to outrage my modesty with the sole intention of gaining sexual favor from me after the marriage alliance between us came to an end.

Thirdly he has physically and verbally assaulted me and has put me into a mental trauma. He has defamed me in my social circle and also has threatened my mothers of dire consequences if I break contact with him. He has even threatened to kill me and also harmed my family (what's up and phone message attached).

He has harassing us mentally regularly via phone calls and message which has put my family into deep mental trauma and the situation has come to this extent that we are fearing to venture out of our home.

He is seeking ransom from us and is threatening to kill us when we refuse the same. He has defamed my family socially.

In consideration to the facts and statement mentioned above I henceforth request your assistance to save us from the continuous fear of life and dignity of me and my family who are simple middle class people and are tremendously suffering for no fault of theirs. My life dignity career and future is at extreme stake. So I beg to you to take immediate action against Sri Debashis Saha and help us live a peaceful human life.
