Sir,

With due respect and in producing herewith the arrested accused person namely Binod Rajak (M/18), S/o- Manoj Rajak of South Shantinagar, Jabravita, PS- NJP, Dist.- Jalpaiguri and following seized articles viz:

- 1) 31 (Thirty one) bottles Of Himalayan Gold Premium 60 up Country Spirit each containing 600 ml in each pack, MRP Rs. 100/- each (Total value Rs. 3,100/-).

I, ASI Binay Subba of NJP PS, Siliguri Police Commissionerate, do hereby lodge this complaint to the effect that on 23/06/2021 at about 20.45 hrs during my special mobile van duty, received a secret source information that one Binod Rajak (M/18), S/o- Manoj Rajak is selling/storing huge quantity of ID liquor at his laundry shop at South Shantinagar for his wrongful gain. Accordingly I informed the fact to O.C. NJP PS, SPC and per his direction myself along with force NVF/0071 Pradyut Roy, CV/460 Sanjib Mandal proceeded for South Shantinagar to work out the information. At about 21.05 hrs being shown by the source myself along with the force had been to the Shop of Binod Rajak at South Shantinagar and found he is selling the illicit liquor illegally from his shop. Hence, we detained him. On interrogation he disclosed his identity as noted above and after searching his shop, found total 31 (thirty one) bottles of Himalayan Gold inside of his shop. On demand he failed to produce any valid documents in respect of the seized articles. Accordingly, I seized all the above noted articles in between 21.25 hrs to 21.35 hrs in presence of witnesses and also arrested the accused person namely Binod Rajak (M/18), S/o- Manoj Rajak of South Shantinagar, Jabravita, PS- NJP, Dist.- Jalpaiguri u/s 41 Cr.P.C after maintaining all the formalities.

Hence, it is evident that the accused person named Binod Rajak (M/18), S/o- Manoj Rajak of South Shantinagar, Jabravita, PS- NJP, Dist.- Jalpaiguri is involved in selling of illicit liquor illegally without any valid license for their wrongful gain.

Therefore, I request that a specific case may kindly be started against the accused person namely Binod Rajak (M/18), S/o- Manoj Rajak of South Shantinagar, Jabravita, PS- NJP, Dist.- Jalpaiguri under proper section of Law and arrange for its investigation.
