At Around 11:30 hrs on 23.06.2021 morning Power House Customer Care center received information regarding damage of electric lines in Singijhora, Toribari area, Siliguri. On reaching the site, the maintenance van of Power House Customer Care Center found that one Vehicle with the no WB-73-E-7850, had broken one Electric Pole and caused other damages to the Electric Lines which are the property of WBSEDCL. The total damages caused by the vehicle are approximately around Rs 23318/- (Rupees Twenty Three Thousand Three Hundred And Eighteen Only).

Thus you are requested to kindly initiate an investigation against vehicle no WB-73-E-7850 under Section 139 of the Indian Electricity act 2003 amended on 2007.
