Sir,

I, SI. Pradip Kr Singha of Ashighar OP under Bhaktinagar PS, Siliguri Police Commissionerate, do hereby lodged this written complaint against one Smt Minati Roy (40) S/O Lt Ranjit Roy of Fakdaibari near Ranjit More PS. Bhaktinagar, Dist. Jalpaiguri after producing him under arrest along with following articles:-

1) 15 (Fifteen) Sealed Bottles Himalayan Gold 60 Up Country Spirit each containing 600 ml Rs. 100/- each (Total Rs. 1500/-) contained in bag under seizure.

In this regard, I beg to report that on 23/06/2021 at 14.45 hrs vide GDE No 633 I along other officer and force while conducting special raid against Illicit liquor received an information that a person is selling illicit liquor in huge quantity in a clandestine way at Fakdaibari Ranjit More. As soon as after receiving information I informed the matter to I/C Bhaktinagar PS and as per his kind order and instruction I conducted raid at Fakdaibari. During raid I found one in the house of Smt Minati Roy is possessing the above noted articles and selling it to the customers since long for wrongful gain. Accordingly, I seized the above noted articles in presence of witnesses, I demanded her the papers or license, cash memo of the said liquor but she failed to produce any documents in support of possession of above noted illicit liquor. On interrogation, she disclosed her name as mentioned above and admitted that she procured the liquor illegally and had been selling the same illegally to the people. I, accordingly, seized those illicit liquors U/S 102 CrPC in presence of witnesses after preparing proper seizure List duly signed by the witnesses and accused, also labeled the same. Then, I arrested her U/S 41 CrPC after maintaining all formalities. The whole process completed in between 16.05 to 16.15hrs.

As the above noted seized articles are to be suspected be of Illicit Origin and possessing the same illicitly. I, therefore, pray before your kind honour to take legal action against her under proper section of law.
