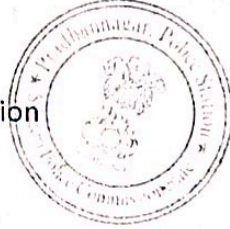

Sir,

In producing here with five arrested accused persons namely namely i) Bijay Choudhary (35) s/o Rajesh Choudhary of Gajipur PS- Gajipur, Dist-Baliya, Bihar, ii) Sonu Kumar Varma (30) s/o Anil Kumar Varma of Gajipur PS Gajipur Dist Baliya Bihar, 3) Bikash Gupta (24) s/o Rajendra kumar Gupta of Champasari, Near Naya Basti PS- Pradhannagar, Dist-Darjeeling, 4) Ajay Kumar (28) s/o Ram Pravash Kumar of Diesel Colony, Ward No. 01 PS-Pradhannagar, Dist-Darjeeling, 5) Dharmendar Thakur (40) s/o Laldeb Thakur of Bela Pachasiya PS- Aniyapur, Dist-Mujafarpur, Bihar arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to complain that on 24.06.2021 while performing special van duty vide Pradhannagar PS GDE No. 1310 Dt. 24.06.2021 myself along with force had been to Darjeeling More and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-647-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19.

I, finding no other alternative, along with force apprehended them and I arrest them U/S 41C.rPC. On interrogation, they disclosed their names and address as noted above. On further grilling, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
