I PSI Youel lepcha of Pradhan Nagar Police Station under Siliguri Police Commissionerate do here by lodge this written complaint to the effect that today i.e 24.06.2021 during my mobile van duty along with forces of Pradhannagar Police Station had been to champasari area, PS-Pradhan nagar, Darjeeling and found the above noted persons were roaming around without wearing mask and maintaining social distance.

On being asked the above noted persons stated before me that they had well to aware of the pandemic situation and they supposed to remain in home and not to come out without any reason. Hence, they violated the order for combating the spread of COVID- 19 as per order of Govt of West- Bengal vide order No 647-ISS/2M-22/2020 dated 15.05.2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June ,2020 and Memo No 486-CS/2021 dated 24th April , 2021 in view of break-out of pandemic COVID-19 throughout the country as well as State.

Accordingly, I arrested them u/s 41 CR.P.C in c/w the above case. Hence, I request you for starting a specific case against the above noted arrested persons and arranged to proper investigation of the case.
