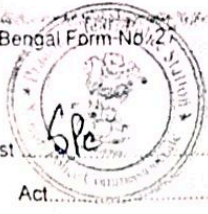

Bhagulpur , Bihar (2)Kundan Singh (M-26) S/O Kapil Singh od Rajendta Nagar , Cooliepara, P.S- Pradhan Nagar, Dist Darjeeling. (3)Kamani Roy (M-46) S/O Chitaranjan Roy of Vidya Nagar Colony, Champasari, P.S- Pradhan Nagar, Dist Darjeeling. (4)Rintu Ghosh (M-24) S/OLt. Santosh Ghosh of Baghajatin Colony, P.S- Pradhan Nagar, Dist Darjeeling.(5) Mahindra Bind (M-45) S/O Rama Bind of Gajipur, Dist. Balia , Uttar Pradesh. Arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to complain that on 24.06.2021 while performing van duty I along with force had been to Siliguri Junction and found that the above noted persons were gathering and loitering without wearing mask. As they violated the order No.-647-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. I, finding no other alternative, I arrest them U/S 41 C.r.P.C. On interrogation, they disclosed their names and address as noted above. On further interrogation, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
