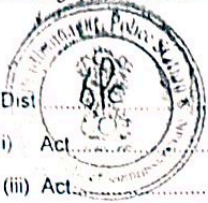

Sir,

With due respect I, SI(UB) Uday Shankar Mondal of Junction Traffic Guard SPC producing herewith the accused persons namely :1. Shankar Sarkar (Male/50 Years), S/o: Lt. Ram Ch. Sarkar of Diary Farm, P.O: Khidirpur, P.S: Balurghat, Dist: Dakshin Dinajpur.2. Bharat Das (Male/35 Years), S/O: Lt. Montu Das of Kalikrishna Thakur Bagan, Sithir More , P.O + P.S: Baranagar , Ward No:23, 17 No. B.T Road, Kolkata-50 along with seizure list.

The fact is that on 24.06.2021 at 19:45 hrs in course of performing Traffic regulation duty and special Naka checking at Darjeeling More under Junction Traffic Guard, P.S:Pradhan Nagar, Dist: Darjeeling vide Junction Traffic Guard, GDE No 325 Dt: 24.06.2021 found that one Passenger Carrying Kolkata bound Bus having Registration No: WB73 F 0330 (Hill Queen) was coming towards Darjeeling More. After detaining that vehicle and on being asked, the passenger stated that they were proceeding towards Kolkata. Accordingly the same thing stated by the driver and conductor and they failed to produce any valid permission which was issued by the Govt. Authority for the said journey.


Therefore, in order to restrict the unnecessary movement of vehicular traffic for combating the spread of COVID-19 as per order of Chief Secretary Govt. of West Bengal vide order No. H & FW/120 Dt:22.03.2020 & MHA order No.40-3/2020-DM-I(A) Dated 24.03.2020, loitering, and plying of vehicle without getting any precautionary measures for combating the spread of COVID-19, as the order has already been promulgated Nationwide in order to combating the spread of COVID-19. I finding no any alternative way arrested the above noted accused person U/S-41Cr.P.C and seized the vehicle Bearing registration no WB 73F0330 along with relevant document under proper seizure list. Accordingly informed the reason of arrest.

I, therefore, request you to kindly start a specific Case against the above noted accused persons as per law and arrange for its investigation
