Being a law-abiding citizen having every respect to the constitution and existing laws of the land, I like to draw your kind attention that on 22/06/2021 an interview of the M.L. A Smt. SIKHA CHATTERJEE who has been elected from 19 Dabgram Fulbari constituency, was conducted by ABP ANANDA Bengali news channel on and also an interview a well circulated news channel. In the said interview Smt. Sikha Chatterjee categorically spoke for segregating the North Bengal from the State of West Bengal which expression hatred, contempt and disaffection towards the existing lawfully elected Government of West Bengal which have the pernicious tendency or intention of creating public disorder or disturbance of law and order.

Such utterances on the part of an elected M.L.A have already been caused public disorders resulting Political violence amongst the public at large, thereby common people of this state including entire North Bengal have been effected for such hatred, excited and disaffection expression towards the existing Government of the state resulting breach of public peace and tranquillity and imminent danger of loss of human lives in the North Bengal including the area of 19 Dabgram Fulbari Assembly Constituency.
