Secy (Tr) dated- 26.05.20. During checking found the above name accused person riding in the bear with three passenger excluding them (Driver) violation the order of transport department Govt. of West Bengal.

Hence they violated the said order, As such I arrest them u/s 41 CR.P.C after informing him about the ground of arrest. Also seized the said vehicle duly signed by the witness and a copy of seizure list supplied to him under proper receipt.

Under above circumstances, it is prayed that a specific case U/S-188 IPC, R/W Sec 51(b) of Disaster management Act-2005 may kindly be started against the above named arrested person and arrange for its investigation
