Sir,

In producing herewith one (01) person namely Ram Dulal Paul (53), S/O- Lt. Ratan Paul of Paul Para, PO+PS- Matigara, Dist- Darjeeling along with seized articles viz., 11 (eleven) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 6.6 liters, value Rs 1100/-), I ASI -Subhendu Das presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodge this written complaint against the above noted person that today (26.06.2021) at 21.35 hrs while performing Special Mobile duty, myself along with C/1035 Santosh Rabidas, CV/155 Sukumar Das and CV/387 Sukumar Barman, had been to Paul Para area and found that the selling and storing of liquor was going on at the shop of the aforesaid person. Then I cordoned the shop with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he is the owner of the shop. On being search of his shop in presence of available witnesses the above noted seized article are found inside his shop. On being asked he failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned articles under proper seizure list in presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person. While on the time of cordoning off the place the persons who were having liquor at the shop manage to flee from the spot. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 21.55 hrs to 22.15 hrs.

Therefore I pray before your good self that a specific case against the above noted accused person namely Ram Dulal Paul (53), S/O- Lt. Ratan Paul of Paul Para, PO+PS- Matigara, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.
