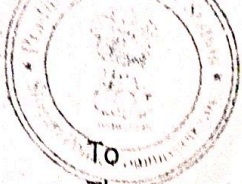

In producing here with six arrested accused persons namely 1)Faijal Haque(18) S/O Samal Haque of Champasari more P.S Pradhan nagar Dist Darjeeling.2)Ashutosh Gupta(36) S/O Gaurishankar gupta of Narmadanagan Champasari P.S Pradhan Nagar Dist Darjeeling.3)Md Muktr Qurishe(30) S/O Md Hamlim Qurishe of Gate Bazar Ward no 1 SMC P.S Pradhan nagar Dist Darjeeling.4)Sourav Singha(22) S/O Lt Anil Singha of new Pokaijote P.S Pradhan nagar Dist Darjeeling .5)Amit Poddar(18) S/O Shasan Poddar of Coolipara P.S Pradhan nagar Dist Darjeeling .6)Chandan Choudhary(18) S/O Prayag la| Choudhary of Panchanam colony P.S Pradhan nagar Dist Darjeeling arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to complain that on 25.06.2021 while performing K31-II van duty received information that some persons were loitering with out gathering mask at Darjeeling More. I along with ASI Debasish Das, ASI Ashit Kr. Singh and force had been to Silliguri Junction and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-647-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3<sup>rd</sup> June, 2020 and Memo No 486-CS/2021 dated 24<sup>th</sup> April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19.

I, finding no other alternative, along with force apprehended them and I arrest them U/S 41C.rPC. On interrogation, they disclosed their names and address as noted above. On further grilling, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
