Sub: - First Information Report regarding seizure suspected of 1.60 kgs opium, 860 gram Brown sugar, 360 nos drug medicines name yaba and apprehension of two persons with seized items.

It is to inform you that today on 26/06/2020 at about 0950 hrs a specific information received from reliable source of SHQ Ranidanga that two person are about to moving with prohibited Drug items may be "BROWN SUGAR " in the area panighata More, Distt Darjeeling (WB) India. On the basis of input received, a special operation team consisting under the supervision of Shri Deepak Tomer, Assistant Commandant & 06 Other Ranks namely 1)HC/GD L.PREM CHAND SINGH, 2) CT/GD SABIN KUMAR 3) CT/GD LAL BAHADUR BOHORA, 4) CT/GD DEEPAK POWER, 5) PROBHAS DAS 6) CT/DVR- M.SAMAJIT, (Vehicle No. UP 46 G 0072) all of "F Coy 8TH Bn SSB Baramaniram Jote reached at aforesaid place at 1045 hrs. and conducted a special operation and identified two person with vehicle maruti suzuki WB 77 8847at the location in the area panighata more (upper Bagdogra) found moving in suspicious manner. The special operation team gave its identity to suspected vehicle stop and asked about the identity of the suspected persons and the items inside the vehicle, on opening the trunk(boot) of the vehicle, one plastic carry bag found ,inside the packet liquid type (suspected opium),medicine pills(suspected yaba tablets) & powdery substance(suspected brown suger) packed. When the suspected person asked about the details of the liquid type & powdery substance they could not give satisfactory reply and also could not give details about the source of the substance which was in their possession. The SSB OPS team asked about any authority or permission to carry the suspected opium, brown sugar and drug medicines but he failed to produce any letter of authority and permission .Further on the spot liquid type substance suspected opium, brown sugar, drug medicines are weighed in an electronic weighting machine available in team and the one suspected opium packet found weighted 1 kg. 60 gram another was 860 grams suspected brown sugar and 360 nos drug medicines. The liquid type & powdery substance were tested after the permission of the suspected person namely Manoj Acharjee and Alabhin indewar lohar with the help of trained Narcotics detection dog and drug detection kit available and metro dog and drug detection kit gave positive indication of drug inside the packet. Accordingly the suspected drug items were


seized at about 11.15 Hrs. During the entire process Shri. Deepak Tomer Assistant Commandant of 8th Bn SSB was also present.


Two sample of about 5 grams was taken from the mother packet of opium & brown sugar & 02 nos drug tablets and all of the mother packet and sample packet were labeled in the presence of witness and apprehended 02 person. The packets were sealed and labeled and signature in this regard made by the SSB OPS team members and apprehended person.

During the spot interrogation they revealed name as (i) Manoj Acharjee (54years) son of Manindra Nath Acharjee, village-Royapara Post- Naxalbari, PS.-naxalbari Dist-darjeeling(W.B) S(ii) Alabhin indewar lohar son of palton indewar lohar VPO-Belgachi ps-Naxalbari dist- Darjeeling (W.B) they received that items from unknown person after a brief return near Panighata more area. Medical examination of 02 apprehended person have been carried out in Bagdogra Hospital. The FIR in this regard is being submitted along with the apprehended two person Manoj Acharjee and Alabhin indewar lohar and seized articles suspected to be opium, brown sugar, drug medicines with seizure memo for lodging FIR in your police station under specific section of law against the apprehended two person.
