Sir,  
In producing here with the person namely Prakesh Rai s/o. Rakesh Rai of Stalin Nagar road no-4, Bagdogra, Dist- Darjeeling along with one grey coloured Honda Activa scooter which bearing registration number W3 74 AT 1414. I do hereby lodged a written complaint against the above noted person pertaining to the effect that on 26.06.2021 in course of performing traffic duty at Bihar more under Bagdogra P.S in order to restrict unnecessary movement of vehicle traffic for combating spread of covid-19 as per order of Chief Secretary govt of W.B vide order no- FW/120 dt- 22.03.20 & MHM order no- 40-3/2020 DM-1(I) dated 24.03.20 found him loitering riding two wheelers without any valid reason or authority though order has already been promulgated nationwide in order to combat the spread of covid-19. Hence he violated the said order and I arrested him u/s- 41(1)(a) Cr.P.C after properly briefing him about the ground of arrest & supplied memo of arrest. Accordingly I also seized his bike after preparing proper seizure list duly arrested by the witnesses & released him on bail & give zimma his seized bike on zimma name other order of superior.
