In producing herewith one accused person namely Sushanta Roy (45), s/o- Late Milan Roy of Fakdaibari Ranjit More PS Bhaktinagar Dist Jalpaiguri and the following articles under seizure:

- (1) 40 (Fourty) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML. MRP Rs.100/- (Total-24 Liter & Amount Rs 4000/-)
- (2) One TVS NTORQ scooter bearing registration no. WB74/BA 2981 black & red coloured.

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Sushanta Roy (45), s/o- Late Milan Roy of Fakdaibari Ranjit More PS Bhaktinagar Dist Jalpaiguri to the effect that, on 25.06.2021 evening as per order of O/C Ashighar OP I along with ASI Sumit Baran Nath C/ 877 Munna Ahamed, and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashighar OP as per order vide Ashighar OP GDE no. 667, Dt 25.06.2021 in course of which I received information from my source that one Sushanta Roy loaded huge numbers of bottles of liquor inside his Scooty bearing registration no. WB74/BA 2981 and selling the said bottles of liquor to the local youth of Fakdaibari Ranjit More area in higher rate by riding his said Scooty. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Fakdaibari Ranjit More area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinagar Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjn Nager w/no 36 PS Bhaktinagar Dist Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Fakdaibari Ranjit More area found that the above noted accused person Sushanta Roy selling bottles of liquor by riding his Scooty bearing regd no. WB74/BA 2981. I along with my accompanied party surrounded the above noted accused person. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him with his said scooty. I search the scooty bearing regd no. WB74/BA 2981, in course of which I recovered the above noted bottles of liquor from inside his said scooty. I seized the above noted bottles of liquor as well as Scooty bearing regd no. WB74/BA 2981 as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession & selling of such bottles of liquor. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 16.45 hrs and 17.20 hrs on 25.06.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Sushanta Roy (45), s/o- Late Milan Roy of Fakdaibari Ranjit More PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
