

in course of performing traffic duty at Kharprai more under
Matigara P.S in order to restrict unnecessary movement of vehicle
traffic for combating spread of COVID-19 as per order of chief-
Secretary govt. of WB vide order no. F.W/120 dated 22.03.20 and
MHA order no 40.3/2020 DM-1(A) dated 24.03.20 found them loiter
ing riding motor cycle without any valid reason or authority
though order has already been promulgated nationwide in order
to combating the spread of COVID-19 Hence they violated the said
order and I arrested them u/s 41(1)(a) Cr. P.C after properly briefin
