Sir,

In producing herewith one arrested accused person namely Raj Kumar Mahato @ Amit (28) s/o Lt. Dev Narayan Mahato of Dharamnagar Coolie Para, Ward No. 01 , P.S-Pradhan nagar, Dist- Darjeeling along with seized articles viz i) 30(thirty) bottles of Himalayan Gold 60up Country spirit each bottle containing 600 ml, ii) 17(seventeen) bottles of Himalayan Gold 60up Country spirit each bottle containing 300 ml, (iii) 48(forty eight) Pouch pack Officers Choice Deluxe Whiskey each containing 180 ml, iv) 09 (nine) bottles of McDowel No-1, Whisky each bottle containing 180 ML, v) 12 (twelve) bottle of Kingfisher Strong Beer each bottle containing 650 ml. under proper seizure list.

I , ASI Ashit Kr. Singha of Pradhannagar PS, Siliguri Police Commissionerate , do hereby lodge this written complaint against the above noted accused person to the effect that on 26.06.21 at 19.10 hrs received a secret source information that one person has stored and illegally selling liquor inside his house situated at Dharamnagar Coolie Par Ward No. 01 , P.S. Pradhan nagar, Dist- Darjeeling without any valid license . I shared the information with you and as per your kind direction myself along with other officers and CV 131 Ranjan Sharma, CV 646 Baban Das had been to the spot to verify the veracity of the information vide GDE No-1461 dtd 26.06.2021. On reaching at the spot I tried to call two disinterested witnesses but due to lockdown nobody was present there to accompany us. Being identified by the source, we cordoned the house and held raid and apprehended the above noted person and recovered the above noted liquors. On demand the said person failed to produce any valid document in respect of the recovered liquors. On further grilling he stated that he had been selling liquors illegally since long for his illegal gain. So, I seized the recovered liquors under proper seizure list and arrested the apprehended person following all the formalities of arrest. The seizure was made between 19:35 hrs to 19:55 hrs.

Hence, I request you to start a specific case against the arrested accused namely Raj Kumar Mahato@ Amit Mahato (28) s/o Lt. Dev Narayan Mahato of Dharamnagar Coolie Para, Ward No. 01, P.S-Pradhan nagar, Dist- Darjeeling and kindly arrange for its investigation.


