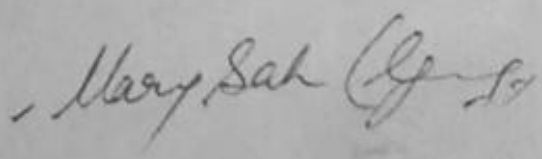
SUBJECT - F. I. R.

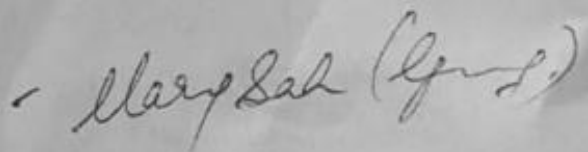
