Sir,
In producing here with the person namely Goutam Barman s/o. Sukra Barman of Rupsing Dakshin, Gossainpur P.S. Bagdogra Dist-Darjeeling along with one black colour Hero Splender which bearing registration no. 2724(MPC) I do here by lodge a written complaint against the above noted person pertaining to the effect that on 29.06.21 in course of performing traffic duty at Bihar more under Bagdogra P.S in order to restrict unnecessary movement of vehicle traffic for combating spread of covid-19 as per order of Chief Secretary Govt. of W.B vide order no. H & FW/120 dt. 22.03.20 & MHA order no. 40-3/2020 DM (1) dt. 24.03.20 found him loitering riding two wheels without any valid reason authority though order has already been promulgated nationwide in order to combating the spread of covid-19. Hence he violated the said order & I arrested him u/s-41(1)(a) Cr.P.C after properly briefing him about the ground of arrest and supplied him memo of arrest. Accordingly I also seized his bike after preparing proper seizure list duly arrested by the witnesses & released him on bail & gave zimmanama his seized on zimmanama as per order.

Hence I would therefore request you to kindly start a specific case u/s-188 IPC R/W Section 51(b) of Disaster Management Act 2005 against the above noted accused person & oblige.
