Sir,

I, ASI Debasish Das of Pradhannagar P.S., Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one (01) accused persons namely Gopal Sharma (32), S/O- Lt Nandlal Sharman of Milan more ghat, P.S.- Pradhan nagar, Dist- Darjeeling, along i) 12 (Twelve) bottles of Black Label Strong premium Beer containing 650 ml each, ii) 12 (Twelve) bottles of Himalayan Gold 60 up Country Spirit containing 600 ml each, iii) 12 (Twelve) pouches of Officer's Choice Delux Whisky containing 180 ml each, which has been seized under proper seizure list (enclosed herewith), to the effect that on 27.06.06.2021 at 08.55 hrs I received secret source information that one person is selling illegal liquors through his house cum shop at Milan more. Accordingly I informed the matter to you and as per your kind direction myself along with ASI Ratan Pradhan, ASI Ashit Singha, CV-128 Ajay Kumar Sahani, CV-131 Ranjan Sharma, all of Pradhan nagar P.S. left for Milan more to verify the veracity of the source information vide Pradhan nagar P.S. GDE. No. 1506, Dated- 27.06.2021 at 09.05 hrs. On reaching at the spot at 09.25 hrs and after being confirmed by the sources, I apprehended lady accused person namely Gopal Sharma. Accordingly, search has been conducted and from inside the house cum shop of Gopal Sharma I recovered i) 12 (Twelve) bottles of Black Label Strong premium Beer containing 650 ml each, ii) 12 (Twelve) bottles of Himalayan Gold 60 up Country Spirit containing 600 ml each, iii) 12 (Twelve) pouches of Officer's Choice Delux Whisky containing 180 ml each. On demand said Gopal Sharma failed to produce any such document in respect of recovered liquors. On interrogation it was learnt that since a long time he was selling illegal liquors to public, without any document or valid license for his illegal gain. It is a violation under Bengal Excise Act. I accordingly seized the said liquors from the apprehended person, under proper seizure List. This seizure was made in between 09.45 hrs to 10.30 hrs. Accordingly I arrested the accused person namely Gopal Sharma (32), S/O- Lt Nandlal Sharman of Milan more ghat, P.S.- Pradhan nagar, Dist- Darjeeling, after preparing memo of arrest and intimating the ground of arrest. At 10.50 hrs the arrested accused person along with seized articles has taken to P.S.


Therefore, I request you to start a specific case under proper section of law against the arrested accused person namely Gopal Sharma (32), S/O- Lt Nandlal Sharman of Milan more ghat, P.S.- Pradhan nagar, Dist- Darjeeling and arrange for it's investigation.
