Sir,

In producing herewith one accused person namely Ashit Kumar Paul(30) S/O Sri Ashoke Kumar Paul of Haiderpara, Seema Sarani, W/N-39, PS- Bhaktinagar Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. Four (04) Bottles of Royal Stage Delux Whisky (each bottle containing 750 ML).
2. Six (06) Bottles of Royal Blue Premium Whisky (each bottle containing 750 ML).
3. Two (02) Bottle of Sterling Reserve Premium WhiskysB7 (each bottle containing 750 ML).
4. One (01) Bottle of McDowells No-1 Luxury Premium Whisky (each bottle containing 750 ML).

I, ASI Biswajit Saha of Bhaktinagar PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 25.06.2021 at 22.30 hrs received a source information that at Ma Tara Motor Cycle Garage, Haiderpara Seema Sarani, w/n-39, PS- Bhaktinagar, Dist-Jalpaiguri have gathered huge amount of liquor illegally in the open market for selling the same in the customer for his wrongful gain. This refers to Bhaktinagar PS GDE No-1655 Dated 26.06.2021. I informed I/C Bhaktinagara about the information. As per his kind instruction I along with ASI Biplab Kumar Das, CV-14 Labanyamoy Barman and CVF/ 619 Dharmendra Roy as preceded at Lower Bhanu Nagar to work out the information. At 22.40 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Ma Tara Motor Cycle Garage, Haiderpara Seema Sarani and recovered the above noted articles from the possession of above noted accused person namely Ashit Kumar Paul(30). On demand he could not produce any valid license/documents in support of said liquor. He became nervous and admitted his guilt before us and stated that he sells the same in the customer since long for his wrongful gain. In presence of witnesses namely Ranjan Dutta s/o Sri Rabi Dutta of Haiderpara Anandamoyee Kalibari Road, w/n-40 PS - Bhaktinagar, Dist.-Jalpaiguri. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 22.50 hrs to 23.35 hrs. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Ashit Kumar Paul(30) S/O Sri Ashoke Kumar Paul of Haiderpara, Seema Sarani, W/N-39, PS- Bhaktinagar Dist- Jalpaiguri under proper section of law.
