With due respect I, **SRI SARJU BASFORE DOME**, S/o Late Nathuni Basfore Dome, presently residing at Shastri Nagar, Green Park, Opposite Eurokids, Iskcon Mandir Road Ward No. 41, P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri, would like to lodge this written complaint to the effect that I along with my wife and two children namely Gita Basfore and Dinesh Basfore reside at the above mentioned address. I and my wife both are senior citizens and suffering from various age related ailments and my wife needs support for her regular works, acts etc. and she is totally dependent upon me and my younger son and daughter. That before staying at Iskcon Road, we used to reside at our another house situated at Ashik Ghat, Bidya chakra Colony and my elder son got married in the year of 1999 on an from the said house of Bidya Chakra Colony and soon after the marriage of my elder son namely Ganesh Basfore some differences were cropped up between him and his wife and my daughter in-law namely Smt. Anita Basfore always picked up quarrel with my son in the house and as a result it was become a daily routine acts as because my daughter-in-law and son were keep fighting on every tripling issues and as a result I had to purchase another land from my hardly earned money and spending all my savings for me and I had to shift at the above mentioned address at Iskcon Road, Shastri Nagar Ward No. 41 SMC. That my daughter in-law namely Smt. Anita Basfore always comes after her quarrel to our residence at Iskcon Road and picks up quarrels with me and my wife and uses filthy languages upon my family without any just cause and reason and my elder son never looks after me and my wife and he never pays any maintenance towards us. That whenever I visit at my house at Bidya Chakra Colony my Son and his wife both of them block my road so that I cannot enter into my said house and moreover my daughter-in-law threatens me of dire consequences. That on 03.05.2021 my daughter in-law came to my house at near Iskcon Road and enter forcefully

along with her brothers and sister and they all were creating pressure upon me to transfer the property in the name of my daughter-in-law and her relatives have also threatened me that if I don't transfer the said property my life will be in danger and they will make my life miserable. I am a senior citizen and I have exclusive right, title and interest upon my both properties which were purchased by my hardly earned money and I am paying the Municipality taxes and Electricity connection is also in my name and hence no one can occupy it illegally or create pressure upon me by using force to transfer my property in their favor.

That yesterday I went to visit my house at Bidya Chakra Colony my son and his wife locked the gate from inside and did not allow me to enter in my own house and again my daughter-in-law was pressurizing me to transfer the property in her favor.

I and my wife being the senior citizens apprehending that the above mentioned persons may again come to my house as per the instruction of my daughter-in-law and may harm us.

I, therefore, request you to take necessary legal steps against the aforesaid persons in accordance with law as because I and my wife both are senior citizens and suffering from old aged ailments.
