Sir,

I, SI Uday Chakraborty of Siliguri P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against namely; (1) Dipak Paswan (28) S/O Sri Phudan Paswan of Dakshin Bharat Nagar, Fuleswari, Ward No. 24, PS- Siliguri Dist- Darjeeling (2) Tapash Mahanta (19) S/O Late Ram Mohan Mahanta of Durgadas Colony, Ward No. 20, PS- Siliguri, Dist- Darjeeling, (3) Abhijit Roy (19) S/O Sri Khitish Roy of Matangini Colony -II, Tikiapara, Ward No. 28, PS- Siliguri, Dist- Darjeeling (4) Biswajit Majumder (22) S/O Late Uttam Majumder of Dabgram near Matri Sadan Hospital more, Ward No. 23, PS- Siliguri, Dist- Darjeeling, (5) Gopal Das (25) S/O Late Kalachand Das of Prankrishna Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling and (6) Surajit Chakraborty (25) S/O Sri Dilip Chakraborty of Dakshin Santi Nagar near Durga Mandir road, PS- Bhaktinagar, Dist- Jalpaiguri under arrest along with following seizure articles; (i) One (01) knife measuring approx. 14" including handle recovered from the possession of Dipak Paswan (knife was on his hand) (ii) One iron rod measuring approx. 30" pointed at one end (seemed to be implement of house breaking) recovered from Tapash Mahanta, (iii) One Dao (Sharp Cutting weapon) measuring approx. 18" including its handle recovered from the possession of Abhijit Roy which he was holding on his hand and (iv) One Sword measuring approx 26 "including handle recovered from the possession of Gopal Das.

In this regard, I beg to report that on 23.06.21 at 01:25 hrs received secret reliable source information that about 10/12 anti socials armed with deadly weapons assembled at Lalmohan Moulick Ghat under Mahananda Bridge of Siliguri PS for making preparation to commit dacoity at Sethsral market area. I informed this source information to IC Siliguri PS and noted the information vide Siliguri PS GDE No. 1399 Dated, 23.06.21. As per the direction of IC Siliguri PS, at 01.35 hrs, I along with ASI Siben Sarkar, ASI Subir Sen, CV/283 Prosenjit Dey, CV-622 Ramanath Barman left for working out the information vide Siliguri PS GDE No. 1400 Dtd. 23.06.21 after briefing officers and force properly and also along with required papers / articles. At 01.45 around hrs we reached at Lalmohan Moulick Ghat under Mahananda Bridge and kept our vehicle at considerable distance. Then, I along with Officers and force headed towards Lalmohan Moulick Ghat under Mahananda Bridge looking for witnesses, if any on the way and found nothing. By this time we reached Lalmohan Moulick Ghat under Mahananda Bridge, as informed by secret source, we could see a group of

persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted six persons could be apprehended and detained them. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with 6/7 others assembled at the spot making preparation to commit dacoity tonight at Sethsralal market area. I accordingly searched them in presence of witnesses and found (i) One (01) knife measuring approx. 14" including handle recovered from the possession of Dipak Paswan (knife was on his hand) (ii) One iron rod measuring approx. 30" pointed at one end (seemed to be implement of house breaking) recovered from Tapash Mahanta, (iii) One Dao (Sharp Cutting weapon) measuring approx. 18" including its handle recovered from the possession of Abhijit Roy which he was holding on his hand and (iv) One Sword measuring approx 26 "including handle recovered from the possession of Gopal Das were making preparation for committing Dacoity tonight in Sethsralal market area but others managed to escape. Accordingly, I seized above noted weapons in presence of above mentioned witness under proper seizure list duly signed by them and labeled the same and arrested them informing them their ground of arrest preparing memo of arrest. The seizure and label was made in between 02.05 hrs to 02.55 hrs of dated 23.06.21.


From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity at nearby Sethsralal market area.

Further, it to mention here that the arrested accused persons are well known anti socials and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against them and 7/9 others who fled away under proper section of law and to cause its investigation.
