In producing herewith six (06) arrested accused persons who disclosed their names as as (i) Sunil Kr Agarwal (38 yrs) S/O- Bishu Agarwal of Milanpally, near RBS Club, Ward No-25, PS-Siliguri, Dist-Darjeeling, (ii) Subir Sarkar (38yrs) S/O- Partha Sarkar of MR Road, Khalpara, near Samsia High Madrasha, Ward No-8, PS-Siliguri, Dist-Darjeeling, (iii) Om Prakash Poddar (35yrs) S/O- Bhola Nath Poddar of Central Colony, near NJP PS, PS-NJP, Dist-Jalpaiguri, (iv) Nakul ghosh (24yrs) S/O- Lt. Gopal Ghosh of Suryasen Colony, near More Bazar, Block-E, PS-NJP, Dist-Jalpaiguri, (v) Sankar Roy (18yrs) S/O- Manoj Roy of Railway Hospital More, PS-NJP, Dist-Jalpaiguri, (vi) Manoj Sahani (28 yrs) S/O- Jaharlal Sahani of Baribhasa near Madani Bazar, PS-NJP, Dist-Jalpaiguri alongwith their six vehicles viz- (i) One Tata Ace vehicle bearing No- WB 73F/9130, (ii) Toto green & yellow colour bearing No- WB 71B/6101, (iii) Toto light green colour without number, (iv) Toto blue colour without number & (v) Toto green yellow colour without number. I, SI Uttam Kumar Baghira of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 23.06.2021 at 18.05 hrs during my Mobile Van duty myself alongwith my accompanied force had been to Venus More, Siliguri and found the above noted persons were roaming without wearing mask on their face and without any proper reasons.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
