Ramnarayan Karan of Baniakhari, PS-MTG, Dist-DJG, (iv) Khirod Barman (30), S/O Purna Barman of Baniakhari, PS-MTG, Dist-DJG arrested u/s 41 Cr.P.C.

I, SI Subir Chowdhury of Matigara PS SPC to the effect that on 30.06.2021 during performing Mobile Van duty at Barsana Naka Pint area he found four persons namely (i) Ramjan Hoque (35), S/O Md. Mashir of Baropotia, P.S - Islampur, Dist - Uttar Dinajpur, (ii) Rakesh Sarkar (32), S/O Lt. Narayan Sarkar of Setelight Town ship, PS-BKN, Dist-JPG, (iii) Pawan Kr. Karan (60), S/O Lt. Ramnarayan Karan of Baniakhari, PS-MTG, Dist-DJG, (iv) Khirod Barman (30), S/O Purna Barman of Baniakhari, PS-MTG, Dist-DJG under proper section of law and arrange for its investigation.
