In producing herewith six (06) arrested accused persons who disclosed their name & identity as as (i) Pachu Gopal Saha (36yrs) S/O-Lt Shyama Prasad Saha of Shaktigarh Road No-3, PS-NJP, Dist- Jalpaiguri (ii) Tat Taru Barman (47yrs) S/O- Lt. Rajni Barman of Patiram Jote, near SKS Primary School, PS-Matigara, Dist-Darjeeling, (iii) Md Mukshed Ali (36yrs) S/O- Md Sammad Ali of Panchanan Bridge, near Hanuman Mandir, PS-Matigara, Dist-Darjeeling (iv) Yash Roy (18yrs) S/O- Dipak Roy of Jabravita near IOC Gate, PS-NJP, Dist-Jalpaiguri (v) Rajiv Sk (25yrs) S/O- Lt Kaltu Sk of Ramghat, Naturnpara, Ward No-5, PS-Siliguri, Dist-Darjeeling (vi) Samar Biswas (35yrs) S/O- Lt Sarat Biswas of Kawakhali, near Football ground, Medical more, PS-Matigara, Dist-Darjeeling were moving/gathering alongwith their vehicles viz. (i) Toto blue colour bearing No- WB 73F/8195 (ii) Toto blue colour bearing No- WB 73E/2419 (iii) Toto green colour without number (iv) Toto blue colour without number (v) Toto blue colour bearing No- WB 73E/5229, I, SI Swapan Basu Biswas of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 26.06.2021 at 12.05 hrs during my R/T Mobile Van duty had been to S.F Road near Thana More, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding, I arrested above noted persons u/s- 41 Cr.P.C and seized said five Toto in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
