On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster

situation and unlock period. Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22,07,2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021 The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accounding, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities. Now, request you for starting a case u/s: 188/269/270 IPC R/W Sec 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
