With due respect, S. Nupur Golan w/o Ritesh Kumar Agarwal, resident of Sri Kushna Garden, since Station Jyoti Nagar, Ward No. 41, Siliguri, would like to draw your attention in the matter mentioned herein below:

That, I, with my whole family have been living in the above-mentioned address since 2014, since last five years with another resident of our apartment, i.e., Mr. C.P. Chowdhury, s/o unknown, his wife and his two sons, namely Sanju Chowdhury and Rohit Chowdhury, who have been living in the same apartment.

Subject: Complaint

It is pertinent to mention here that since their arrival to this apartment the above mentioned C.P. Chowdhury, his wife and above-mentioned two sons have been trying to make my family's and other residents' life miserable by their conduct and deeds.

That the above-mentioned miscreants live on the Ist floor of the apartment and on a daily basis, one C.P. Chowdhury utters slangs to my family and other families in the apartment. Even after several requests the conduct of C.P. Chowdhury and his family remained unchanged.

That on 24.6.21, Thursday, when I, with my family going down the stairs, the one above-named C.P. Chowdhury and his wife along with their two sons started hurling abusive languages towards my husband and me, stating that they will make our life hell and not let us peacefully live here in our residence. He wrongfully claimed the common stairs of the flat of his own. When I protested against this act, they started coming aggressively and with a piece of wood in their hands and somehow, I along with my two sons, Naitik Agarwal and Kiaan Agarwal fled from their reach. Our neighbour, Mrs. Sonu Agarwal, w/o Bojay Agarwal saw them intimidating us criminally with that said wooden stick.

That at the evening of that said day when I was about to leave my children to my relative's house, while going down their stairs, the one C.P. Chowdhury, who was partly naked, saw me

and my children and started hurling sexually abusive words to me, there my younger son, i.e., Kiaan protested against him and the said C.P. Chowdhury called his sons, Sanju Chowdhury and Rohit Chowdhury to intimidate my little son, where the above-named two sons of Mr. C.P. Chowdhury said with sheer aggressiveness that "we control this building and your family belongs to be under our shoes and also made some sexually abusive gestures to me, by which my younger son became traumatized.

That on 26.6.2021, when my husband, Ritesh Kumar Agarwal was in office, the said Sanju Chowdhury and Rohit Chowdhury took the advantage of the moment and came infront of the door of our flat and tried to enter into my living room. I somehow with the help of my son Naitik Agarwal kept the door shut and did not let him enter our house. After this incident, when I informed my husband about it and even infront of their door to ask explanation about the same, they threatened my husband. As well saying that, it won't even take half an hour to kill my husband and make his body disappear.

In view of the above-mentioned facts, I urge you to take the necessary and proper action against the miscreants and book them under law of the land.
