Sir,

In producing herewith one accused person namely Anirban Roy(23) S/O- Sri Sushil Roy of 2/08 Baghaghajatin Colony ,Purbanchal near Nepali School PS- Pradhannagar Dist- Darjeeling along with the following seized articles as per proper seizure list:

- [1] 29 bottles of Carlsverg Premium Smooth Lager Beer (each bottle containing 650 ML.)
- [2] 29 bottles of Carlsverg Premium Smooth Lager Beer (each bottle containing 330 ML.)
- [3] 30 bottles of kingfisher Ultra Lager Beer (each bottle containing 330 ML) .
- [4] 28 bottles of kingfisher Premium Lager Beer (each bottle containing 330 ML).
- [5] 30 bottles of Hoegaarded Wheat beer (each bottle containing 330 ML) .
- [6] 30 bottles of corona premium beer (each bottle containing 330 ML).
- [7] 06 bottles of Budweiser Premium king of beer (each bottle containing 330 ML)
- [8] 06 bottles of Magic Moment Grain Vodka( each bottle containing 750 ML) .
- [9] 05 bottles of Eriatoff Triple Distilled Premium vodka (each bottle containing of 750 ML) .
- [10] 04 Bottles of Black By Bacardi Deluxe Premium Created Rum (each bottle containing 750 ML).

I, SI Sibdhan Karmakar of Bhaktinagar PS, under Siliguri Police Commissionerate lodged this written complainant against one Anirban Roy(23) S/O- Sri Sushil Roy of 2/08 Baghaghajatin Colony ,Purbanchal near Nepali School PS- Pradhannagar Dist- Darjeeling to the effect that today i.e. on 30.06.2021 at 14.15 hrs received a source information that one person has stored huge quantity of illicit liquor at his Restaurant name and style as "Temperature" in order to sale the same to his design customers illegally for his wrongful gain. Accordingly I diarized the fact vide Bhaktinagar P.S. G.D.E No- 1698 date 30/06/2021 and informed the matter to I/C Bhaktinagar Police Station. As per his kind instruction I along with ASI Biplab Kumar Das, ASI Rabin Lama, CV-14 Labanyamoy Barman and CVF/ 619 Dharmendra Roy left for Planet Mall to verify the veracity of the information. At 14:25 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Temperature Restaurant, Planet Mall and recovered the above noted articles from the possession of above noted accused person namely Anirban Roy(23) S/O- Sri Sushil Roy of 2/08 Baghaghajatin Colony ,Purbanchal near Nepali School PS- Pradhannagar Dist- Darjeeling .On demand he could not produce any valid license/documents in support of said liquor. He became nervous and admitted his guilt and made in coherent statement before us and stated that he sells the same to the customer since last few months for wrongful gain as per order of his owner. I also gave him opportunity to contact and call his owner namely Sushant Tewary for producing any other valid documents in respect of stocking and selling liquor , he tried but mobile phone of Sushant Tiwary found out of area net work as Anirban reported me . Accordingly in presence of witnesses namely Dipak Biswas S/O- Gopal Biswas of Limbu Busty,Prakashnagar PS- Bhaktinagar Dist- Jalpaiguri I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 14.40 hrs to 15.35 hrs. As the accused person and his owner violated rules and norms of Bengal Excise act as such , I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Anirban Roy(23) S/O- Sri Sushil Roy of 2/08 Baghaghajatin Colony ,Purbanchal near Nepali School PS- Pradhannagar Dist- Darjeeling and his owner under proper section of law.
