Sir,

In producing herewith arrested accused person namely Sita Chhetri (50) W/O Rajendra Chhetri of Tikiapara Mazdoor Colony, Matangini-I, Ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized articles vize- i) 25 (twenty five) sealed bottles of Himalayan Gold 60 up country spirit containing 300 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 25 x Rs 50/- =RS.2500/-), ii) 16 sealed bottles of Old Monk Premium XXX Rum containing 180 ml each amounting of Rs. 153 x 16 =Rs.1690/- as per seizure list.

I, SI Uday Chakraborty of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Sita Chhetri (50) W/O Rajendra Chhetri of Tikiapara Mazdoor Colony, Matangini-I, Ward No. 28, PS- Siliguri, Dist- Darjeeling to the effect that on 26.06.21 at 15.15 hrs I received a source information that the above noted person was busy to sale ld liquor illegally at her house situated at Mazdoor Colony, Matangini-I, Ward No. 28 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 1620 dated 26.06.21 and informed the fact to I/C Siliguri PS. As per his direction of I/C Siliguri PS, I along with ASI Subir Sen, LCV/175 Pratima Das, LCV/190 Babita Barman and CV/283 Prosenjit Dey left Matangini-I, Ward No. 28 Siliguri PS vide Siliguri P.S GDE NO: 1621 dated 26.06.21 to verify the veracity of the information. On reaching at 15.35 hrs there and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person with the help of lady constable and on interrogation, the above noted person disclosed her identity as noted above. On searching we i) 25 (twenty five) sealed bottles of Himalayan Gold 60 up country spirit containing 300 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri,

West Bengal @ Rs 100 each (Amounting of 25 x Rs 50/- =RS.2500/-), ii) 16 sealed bottles of Old Monk Premium XXX Rum containing 180 ml each amounting of Rs. 153 x 16 =Rs.1690/- which was kept concealed in her house. On being interrogation she could not produce any valid documents in respect of the said liquor. She also stated that she is doing this liquor business since last ten (10) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 15.45 hrs to 16.45 hrs. On being asked he stated that she used to sale the same to locality without any valid documents as she has violated the norms of Bengal Excise Act as such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules for selling the said seized articles without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Sita Chhetri (50) W/O Rajendra Chhetri of Tikiapara Mazdoor Colony, Matangini-I , ,Ward No. 28, PS- Sillguri, Dist- Darjeeling under proper section of law and arrange for its investigate-
