In producing here with Two (03) Arrested person who disclosed his identity as (1) Anarul Hoque,(Male/39Yrs.)S/O-Late Ainal Hoque of Vill-Kutubganj PO-Kutubganj,PS-Pukuria,Dist-Malda,(2)Alok Roy,(Male)32Yrs.)S/O-Prasanna Roy of Vill+ PO-Pirganj,PS-Pukuria,Dist-Malda,(3)Washim Akram ,(Male/36Yrs.)S/O-Abu Sufian of Vill+ PO-Pirganj,PS-Pukuria, Dist-Malda,under custody along with seized vehicles(1) One White colour Rigid Car Bearing registration No-WB84C-2464,Seized under proper seizer list duly sign by the witness, attached here with I ASI Prodip Kumar Bhowmick of Jalpaimore Traffic Guard, Siliguri Police Commissionerate do here by lodged complaint against the above noted person, to the effect that while on Jalpaimore Traffic duty myself along with force had been to Jalpaimore at about 13.15 hrs. and found that the above noted persons were coming with their respective vehicles. The persons noted above were using the following vehicles noted against their names.

- (1) Anarul Hoque was riding in White colour Rigid Car Bearing registration No-WB84C-2464.

On being asked all the above noted persons stated before me that they were well aware of the lockdown situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local police authority or civil administration.

Hence, they all violated the order of Govt. of India duly promulgated in order no.40/3/2020 DM-1(A) Govt. of India ministry of home affairs Dated 24.03.2020, all the above noted person have intentionally refused to comply with the order of Govt. of india duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Hence I seized their respective vehicles and arrested them in c/w the case.

Now I request you for starting a case U/S-188 IPC,R/W Sec.51 (b) Disaster management Act. 2005 Against (1) Anarul Hoque ,(Male/39Yrs.)S/O-Late Ainal Hoque of Vill-Kutubganj PO-Kutubganj,PS-Pukuria,Dist-Malda,(2)Alok Roy,(Male)32Yrs.)S/O-Prasanna Roy of Vill+ PO-Pirganj,PS-Pukuria, Dist-Malda,(3)Washim Akram ,(Male/36Yrs.)S/O-Abu Sufian of Vill-PO-Pirganj,PS-Pukuria, Dist-Malda,and arranged proper investigation of the case.
