In producing herewith arrested accused person namely Jagdish Sahani (62) S/O Late Badhai Sahani of Mazdoor Colony, Ward No. 28, PS- Siliguri Dist- Darjeeling along with seized articles vize- i) 20 ( twenty ) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 20 x Rs 100/- =RS.2000/-) as per seizure list.

I, SI Hiru Kanti Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Jagdish Sahani (62) S/O Late Badhai Sahani of Mazdoor Colony, Ward No. 28, PS- Siliguri Dist- Darjeeling to the effect that on 26.06.21 at 19.45 hrs I received a source information that the above noted person was busy to sale Id liquor illegally at his house situated at Mazdoor Colony, Ward No. 28 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 1640 dated 26.06.21 and informed the fact to I/C Siliguri PS. As per his direction of I/C Siliguri PS, I along with ASI Subir Sen and CV/283 Prosenjit Dey left Mazdoor Colony, Matangini-I, Ward No. 28 Siliguri PS vide Siliguri P.S GDE NO: 1641 dated 26.06.21 to verify the veracity of the information. On reaching at 20.05 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interogation, the above noted person disclosed his identity as noted above. On searching i) 20 ( twenty ) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 20 x Rs 100/- =RS.2000/-) which was kept concealed in his house. On being interogation she could not produce any valid documents

since last ten (10) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 20.35 hrs to 21.25 hrs. On being asked he stated that he used to sale the same to locality without any valid documents as he has violated the norms of Bengal Excise Act as such I arrested her U/S-41 Cr.P.C after observing all sorts of rules for selling the said seized articles without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Jagdish Sahani (62) S/O Late Badhai Sahani of Mazdoor Colony, Ward No. 28, PS- Siliguri Dist- Darjeeling under proper section of law and arrange for its investigate.
