I, SI Ashim Kr Das of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 27.06.2021 at about 14:25 hrs while performing mobile petrolling duty at Bidhan Market, near Auto Stand area and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Md. Nur Alam (23) S/O Md. Saju of Jhankar More, Near Masjid, Ward No. 04, PS- Siliguri Dist- Darjeeling (2) Jay Jatanta Roy (50) S/O Lt. Jatindra Roy of Purba Dhantala, Dabgram 02, PS- NJP, Dist- Jalpaiguri (3) Alok Barman (26) S/O Lt. Dhiren Barman, of Vill- Dangi, PO + PS - Kumargram, Dist- Alipurduar A/P Bhanunagar, Ward No. 42, PS- Bhaktinagar, Dist- Jalpaiguri (4) Biplab Sarkar (47) S/O Lt. Binay Kr Sarkar of West Ashrampara, Near Sanjibani Nursing Home, Ward No, 10, PS- Siliguri, Dist- Darjeeling (5) Bikash Sharma (22) S/O Badri Sharma of Maharaj Colony, Near Shiv Mandir, Ward No. 05, PS- Siliguri, Dist- Darjeeling.

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and unlock period. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation and unlock period.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities. Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Md. Nur Alam (23) S/O Md.
