Sir,

In producing herewith one arrested accused person namely Buddho Dev Biswas (52/M) S/O- Lt. Dharendra Nath Biswas of- Vidhya Chakra Colony, Near Ghat More, Ward No. 44, PS- Bhaktinagar, Dist- Jalpaiguri along with seized articles (i) 21 (Twenty one) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL. N-) 01

I, ASI Khela Murmu of Panitanki TOP under Siliguri PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 27/06/2021 at 14:55 hrs during special raid duty I received a secret source information that, one person is carrying huge quantity of country spirit through Sevoke Road, Near Army parking. Accordingly I informed the information to OC Panitanki TOP and as per his direction I along with, ASI Biswajit Ghosh, C/576 Binay Ch Roy, CV/1007 Jiten Roy left for PO to work out the information. On arrival at Sevoke Road, Near Army parking at 15:05 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered 21 (Twenty one) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag. On interrogation he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Vidya Chakra Colony and adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 21 (Twenty one) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which was used for carrying the seized articles under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 15:20 hrs to 15:40 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs 2100/-

Hence, under the above circumstances I am submitting this written complaint against the above accused person namely Buddho Dev Biswas (52/M) S/O-Lt. Dharendra Nath Biswas of- Vidhya Chakra Colony, Near Ghat More, Ward No. 44, PS- Bhaktinagar, Dist- Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
