Dear Sir,

I Smt. Neelam Bansal, Wife of Sri Rajesh Bansal, Daughter of Sri Jay Prakash Agarwal, resident of Dena Bag Challa, Katihar, Bihar, at present residing with my husband at 6/44, Sukanta Sarani, East Milan Pally, Babupara, Siliguri, Post Office - Siliguri, Police Station-Siliguri, Darjeeling-734005 would like to state that I got married to Sri Rajesh Bansal on 02.12.2003. Right from the beginning of the marriage I and my husband did not enjoy the marital happiness due to the greedy nature of my husband who was more interested in earning money through dowry demanded from my parents. At the time of my marriage my father used to be a businessman dealing in a small business earning a basic meager income but inspite of that, used to provide some amount in each month to my husband out of an anticipation that this would please my husband and peace would prevail. My father was not a big businessman and had his limitations. The demand of my husband still did not cease and thereafter my brother/s provided him money on various occasions till February, 2020. After six months of the marriage my husband namely Sri Rajesh Bansal started coming to house late at night everyday in an intoxicated state and when intervened by me and questioned by me as to where had he been, my husband used to turn violent and used to beat me with fists and blows. This instance of physical torture continued for years and I have been tolerating the same. On 02.01.2010 our daughter namely Dolly Bansal was born to us and thereafter I believed/ thought that the physical torture done to me by my husband would stop and come to an end. Unfortunately I was wrong. Even after the birth of our child, my husband used to fight with me on every single illogical / irrelevant topic and beat me mercilessly with things and household articles like belt, stick etc.

From the inception of the marriage I was always ill treated and I did not have the respect and dignity of a wife. My husband always abused me with filthy language and still continues to do the same without any reason. In the last 17 years my husband has tried several businesses but due to his behavior with other businessmen and

customers, he has always failed miserably. Eight years back he left his attempts to do business and started doing jobs in local private shops/firms. However due to his unruly behavior he could not sustain his employment at any of the places more than a year. My husband used to ventilate all these frustrations on me unnecessarily. My husband abuses me to the extreme and uses filthy languages very often. The words and languages used by my husband are "3 No ka Randi, Tum customer dhundhund k lati ho, tum hamara ghar kobarbad kardiya, Tum mera jindagi kharab kar di ho, Tum electrician, tailor dono k sath ganda kam karti ho, tumhara hum test karwayga tum kis kis k sath soti ho."

My husband has never provided us anything apart from a square meal. Whenever there is a marital discord/fight between us, he does not allow me to keep my mobile with me with a fear that I might inform my parents and relatives. My father is a paralysis patient, but inspite of the same my husband does not leave any chance to abuse him.

All through my married life I was subjected to both mental and physical tortures by my husband and on each and every occasion my husband unnecessarily starts a fight with me wherein he crosses all limits to use abusive language in front of my 11 years old daughter.

Today at midnight on 29.06.2021 at around 12. a.m. my husband suddenly started quarrels with me on illogical topics and started labeling false all allegations against me that I have stolen my own (stridhan) gold ornaments from the almirah and started beating me with fists and blows. He further grabbed my neck with full force and put his hands on my mouth and also closed my nose with his fingers and tried to choke me with the only intention to kill me. Seeing that my daughter got very nervous and my daughter started screaming with fear. My husband thereafter started abusing me with filthy words and more particularly said "AAJ TUJHE AUR TERI BETI KO MAR DALUNGA". Hearing the screams of my daughter the residents of the building came to my house and rescued me. Thereafter, I was left with no other option but to DIAL in 100. The police van came on the spot (my residence) and took my husband to the Police Station. The mere intention of my husband was to kill me. The residents of the neighborhood flats along with the building owner/landlord have saved my life last night. This sort of torture against me was not done first donetime. I have been facing such kind of physically torture right from the inception of the marriage.

Since my daughter saw the entire incident at night and helped me to save my life, my husband told her that he will not mind even if she dies. Thus, I also fear that my husband might also try to kill my daughter.

I do not have any place to reside except the tenanted premises where I have been residing. The landlord has also told me to vacate the premises I am in constant fear of threat of losing my life and there is every possibility that my husband might attack me once again and kill me and my daughter.

Due to the inhuman acts of my husband, the upbringing of my daughter has also been prejudiced to a great extent. She has been growing up in an environment of hatred and violence witnessing the honour and dignity of a woman being crushed and disrobed on a regular basis. Her education has also been hampered due to these reasons and it is very likely that she would grow up with an abnormal mentality towards life and marriage. The recent developments have now also endangered her life.

My husband has tortured me beyond all limits for his constant demand of dowry since the inception of marriage which is still carrying on and now he has tried to kill me for which he should be punished under law.

I therefore request you to investigate the matter and book the culprit in accordance with the appropriate provisions of law.
