Accordingly, diarized the fact in the General diary vide NJP PS GDE No 1326 . dated 27.06.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Sajal Das, ASI Khagen Barman, C/1053 Paresh Rava, VP/08 Laxman Roy and VP/13 Jamirul Islam left for Jabravita to work out the information in hand. At about 19.45 hrs we arrived at Bhola More and being shown and identified by the source we held raid and managed to apprehended one person. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of the above noted I/D liquor. Accordingly, I seized the above noted I/D liquor from the possession of accused Dipankar Kanjilal S/O late Ram Kanjilal of North Bharat Nagar, PS- Siliguri, Dist.- Darjeeling under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 19.15 hrs to 19.45 hrs on 27.06.21.
