Sir,

With due respect, I am producing herewith the arrested accused person namely Dipankar Kanjilal (32 yrs) S/O late Ram Kanjilal of North Bharat Nagar, PS- Siliguri, Dist.- Darjeeling under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 17 (Seventeen) bottles of 60 up Himalayan Gold Country Spirit containing 600 ML in each bottle of Rs 100/- of each bottle.
2. 04 (Four) bottles of KINGFISHER Strong premium Beer containing 650 ML in each bottle of MRP Rs 130/- of each bottle.

I beg to state that today i.e. on 27.06.21 at 18.30 hrs I received a secret source information that one person named Dipankar Kanjilal of North Bharat Nagar is selling ID liquor illegally at Jabrabhita area for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 1326 dated 27.06.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Sajal Das, ASI Khagen Barman, C/1053 Paresh Rava, VP/08 Laxman Roy and VP/13 Jamirul Islam left for Jabravita to work out the information in hand. At about 19.45 hrs we arrived at Bhola More and being shown and identified by the source we held raid and managed to apprehended one person. During interrogation he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at Jabravita area since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of the above noted I/D liquor. Accordingly, I seized the above noted I/D liquor from the possession of accused Dipankar Kanjilal S/O late Ram Kanjilal of North Bharat Nagar, PS- Siliguri, Dist.- Darjeeling under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 19.15 hrs to 19.45 hrs on 27.06.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Dipankar Kanjilal S/O late Ram Kanjilal of North Bharat Nagar, PS- Siliguri, Dist.- Darjeeling and arrange for its investigation.
