Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Shyamal Madak (50yrs) S/O late Nikhil Madak of Tinbatti More, PO- Siliguri Bazar, Dist.- Jalpaiguri. (ii) Apurba Paddar Datta S/O-Lt. Kalidas Paddar Datta (51years) of Tinbatti More, PO- Siliguri Bazar, Dist.- Jalpaiguri, under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 17 (Seventeen) Cartoons Country Spirit 60 up Himalayan Gold each cartoon in 20 (Twenty) bottle, containing 600 ML in each bottle.
2. 10 (Ten) bottles of Country Spirit 60 up Himalayan Gold containing 600ml in each bottle.

I beg to state that today i.e. on 29.06.21 at 21.35 hrs I received a secret source information that two persons namely (i) Shyamal Madak (50yrs) S/O late Nikhil Madak of Tinbatti More, PO- Siliguri Bazar, Dist.- Jalpaiguri. (ii) Apurba Paddar Datta S/O-Lt. Kalidas Paddar Datta (51years) of Tinbatti More, PO- Siliguri Bazar, Dist.- Jalpaiguri, is selling ID liquor illegally of Suruchi Hotel at Tinbatti more area for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 1430 dated 29.06.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Sajal Das, ASI Khagen Barman, C/1053 Paresh Rava, VP/08 Laxman Roy and VP/13 Jamirul Islam left for Tinbatti more to work out the information in hand. At about 21.50hrs we arrived at Tinbatti More and being shown and identified by the source we held raid and managed to apprehended above noted two persons. During interrogation they disclosed their name and identity as noted above and also disclosed that they is selling ID liquor of Suruchi Hotel at Tinbatti more since long for their illegal gain. On search the above noted I/D liquor recovered from their possession. On demand they failed to produce any documents/licence in respect of the above noted I/D liquor. Accordingly, I seized the above noted I/D liquor from the possession of accused (i) Shyamal Madak (50yrs) S/O late Nikhil Madak of Tinbatti More, PO- Siliguri Bazar, Dist.- Jalpaiguri. (ii) Apurbay Paddar Datta S/O-Lt. Kalidas Paddar Datta (51years) of Tinbatti More, PO- Siliguri Bazar, Dist.- Jalpaiguri under proper seizure list and arrested them under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 22.05 hrs to 22.30 hrs on 29.06.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case, under proper section of law may kindly be started against the arrested accused namely (i) Shyamal Madak (50yrs) S/O late Nikhil Madak of Tinbatti More, PO- Siliguri Bazar, Dist.- Jalpaiguri. (ii) Apurba Paddar Datta S/O-Lt. Kalidas Paddar Datta (51years) of Tinbatti More, PO- Siliguri Bazar, Dist.- Jalpaiguri and arrange for its investigation.
