I, SI Sushanta Dhar of Matigara PS SPC to the effect that on 01.07.2021 during performing Mobile Van duty at Khaprail More under Matigara PS area he found Three persons namely (i) Sibnath Bera (24), S/O Sukumar Bera of Patiramjote, PS-Matigara, Dist - Darjeeling, (ii) Pankaj Gupta (28), S/O Jai Shankar Prasad Gupta of Tumbajote near West Point School, PS-Matigara, Dist- Darjeeling, (iii) Rinku Mandal (38), S/O Ram Shobit Mandal of Sitaram Chowk, Kotaram, Sitaram, Bihar were loitering near Khaprail More under Matigara P.S area without wearing mask and not maintaining social distance and violating the Govt.
