to the effect that on 30.06.2021 between 17:05 hrs to 18:40 hrs in course of performing Traffic regulation duty and special Naka checking at Darjeeling More P.S Pradhan Nagar, Dist: Darjeeling vide Junction Traffic Guard, vide GDE No.419/21 Dt: 30.06.2021 found that they were loitering here and there without wearing any Mask, which may results in the possibilities of spread of Pandemic Corona Virus (COVID-19), as the order has already been promulgated nationwide in order to combating the spread of COVID-19 vide order No. H & FW/120 Dt: 22.05.2020 & MHA order No.40 3/2020-DM-I (A) Dated 24.03.2020 of Chief Secretary Govt of West Bengal, Hence they violated the said order. Finding no any alternative way, I arrested them U/S-41 Cr.PC. after proper briefed them about the ground of arrest and supplied a copy of Memo of Arrest.

Hence, I would, therefore request you to kindly start a specific Case U/S-188 IPC r/w section 51(b) of Disaster management Act 2005 against the above noted accused persons and obliged.
