Sir,

I, ASI Debasish Das of Pradhannagar P.S., Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Sujit Ray (30) S/o Lt. Subhash ray of Samar Nagar PS-Pradhan nagar, Dist- Darjeeling, along with (i) 10(Ten) bottles of Galaxy JOSH 80'up Country Spirit containing 600ml each, which has been seized under proper seizure list (enclosed herewith), to the effect that on 30.06.2021 at 16:50 hrs I received a secret source information that one Sujit Ray (30) S/o Lt. Subhash ray of Samar Nagar PS-Pradhan nagar, Dist- Darjeeling is selling illegal liquor through his shop at his house cum shop. Accordingly I informed the matter to you and as per your kind direction myself along with ASI Ratan Pradhan, CV-128 Ajay Kumar Sahani, CV-131 Ranjan Sharma, CV-223 Sapan Chettri all of Pradhan nagar P.S. left for near Samar Nagar to verify the veracity of the source information vide Pradhan nagar P.S. GDE No1745, Dated 30.06.2021 at 22:10 hrs. On reaching at the spot at 22:30 hrs and after being confirmed by the sources, I apprehended the above noted accused person. On interrogation it could learnt that since a long time he was selling illegal liquors to public, without any document or valid license for his illegal gain. Accordingly, on search his shop cum house and recovered (i) 10(Ten) bottles of Galaxy JOSH 80'up Country Spirit containing 600ml each. On demand Sujit Roy failed to produce any such document in respect of recovered liquors. It is a violation under Bengal Excise Act. I accordingly seized the said liquors from the apprehended person, under proper seizure List duly signed by them and the witnesses. This seizure was made in between 22:45 hrs to 23:00 hrs. Accordingly I arrested the accused person Sujit Ray (30) S/o Lt. Subhash Ray of Samar Nagar PS-Pradhan nagar, Dist- Darjeeling, after preparing memo of arrest and intimating the ground of arrest and brought him at PS with seized articles.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Sujit Ray (30) S/o Lt. Subhash Ray of Samar Nagar PS-Pradhan nagar, Dist- Darjeeling and arrange for it's investigation.
